NOTIFICATION

In exercise of the powers conferred by sub-rule (4) of Rule 99 of the Goa Excise Duty Rules, 1964, the Government of Goa, being satisfied that it is necessary in the public interest, hereby directs that all licensed premises “for the sale of liquor” and “consumption of liquor in public places” located within the jurisdiction of wards as specified in Column no. 4 of the schedule hereto (hereinafter called the said area) located in the Village Panchayat as specified in Column No. 3 of the Talukas as specified in Column 2 of the said schedule shall be closed from 6.00 P.M. of 19th October, 2019 until midnight of 21st October, 2019 in view of the General Election to Maharashtra Legislative Assembly, 2019 and 00.00 hrs of 24/10/2019 till midnight of 24/10/2019 being the day of counting of votes.



However, the licensed premises having licence for "Bar and Restaurant" may be allowed to keep the restaurant open for serving food only and the Bar counter shall be closed and no liquor shall be allowed to be served on the above date. The owners of the license premises having "Bar & Restaurant" shall also display a board in the licenced premises, stating that no liquor will be served and that the restaurant will be open for serving food only.
