#### CITIZEN CHARTER

The Election Commission of India is an Autonomous Constitutional Authority /body established on 25th January, 1950. The Election Commission operates under the authority of Constitution per Article 324, and subsequently enacted Representation of the People Act. ECI is responsible for administering election processes in India. The body administers elections to the Lok Sabha, Rajya Sabha, State Legislative Assemblies in India, and the offices of the President and Vice President in the country including Summary Revision of Photo Electoral Rolls, preparation and issue of Electors' Photo Identity Cards to electors.

Election Commission of India (ECI) is one of the important pillars of the democratic Republic of India that has been conducting elections to parliament and state legislature as an onerous task since 1950. It is through elections that people participate in the formation of the Government. They become the participant in decision-making through elections and therefore Commission always placed its giant efforts to make elections inclusive and transparent across the country.

Over the years, the Commission has made several laudable electoral reforms to strengthen democracy and increase the fairness of elections through the new technologies. So far, the journey of the Information & Communications Technology (ICT) of Commission has been quick in keeping abreast of new technological changes and in introducing improvements in the electoral process.

The election work is supervised, subject to overall superintendence, direction and control of the Commission, by the Chief Electoral Officer of the State, who is appointed by the Commission from amongst senior Civil Servants of the State Government in consultation with the Government concerned.


At the district and constituency levels, the election functionaries are the District Election Officers, Electoral Registration Officers (EROs) and Assistant Electoral Registration Officers (AEROs). They utilize the services of other officials in the performance of the election related work. They all perform their functions related to elections in addition to their other responsibilities.

During the period of their deployment on election related duty, they all are deemed to be on deputation to the Commission and are subject to its superintendence, control and discipline.

## **Organisational structure**

Under Article 324 of the Constitution, the superintendence, direction and control of the preparation of the electoral rolls and the conduct of all elections to the Lok Sabha, Rajya Sabha and to the Legislature of every State and the elections to the offices of President & Vice-President are vested in the Election Commission of India, which consists of the Chief Election Commissioner (CEC) and two Election Commissioners (ECs).

At the State level, the Chief Electoral Officer and the officers and staff working under him supervise the election work subject to the overall superintendence, direction and control of the Election Commission of India.

At the district level, the District Election Officers (DEOs) (District Collector-cum-District Magistrate) and the officers and staff working under him supervise the field work relating to all election related activities subject to the overall superintendence, direction and control of the Chief Electoral Officer.

At the Assembly Constituency level, the Electoral Registration Officers (EROs), assisted by Assistant Electoral Registration Officers (AEROs) and staff working under them are responsible for execution of all election related activities pertaining to preparation & maintenance of electoral rolls in respect of the Assembly Constituencies allotted to them under the overall superintendence, direction and control of the District Electoral Officer.

In so far as the Goa State is concerned, the Electoral Registration Officers are also designated as the Returning Officers (ROs) for the Assembly Constituencies allotted to them. They are assisted by Assistant Returning Officers (AROs) and other officials. As Returning Officers, they are responsible for the conduct of elections under the overall superintendence, direction and control of the District Electoral Officer.

Preparation of Electoral Roll, Electoral Photo Identity Cards (EPIC) The work of preparation and updation of Electoral Rolls, issue of Electoral Photo Identity Card (EPIC) in respect of all 40 Assembly Constituencies in the Goa State and the task of providing other election related services have been entrusted to the Electoral Registration Officers (ERO) under the direction, superintendence and control of the District Election Officers, who will in turn functions under the direction, superintendence and control of the Chief Election Officer. The EROs are assisted by Assistant Electoral Registration Officers (AEROs) and other staff members. The details of the DEOs/ EROs/ROs and AEROs/ AROs are furnished below:-

#### Qualification/condition for registration as elector:-

The Parliament has prescribed specific condition of registration in electoral roll in section 19 of the Representation of the People Act, 1950.

Any person applying for registration as an elector in an assembly or parliamentary constituency must fulfill the following eligibility conditions:

- 1. He must be a citizen of India
- 2. He must not be less than 18 years of age on the qualifying date prescribed by law.
- 3. He should be ordinarily resident in the constituency concerned.
- 4. He must not be disqualified for such registration under the law made by Parliament.

## Disqualification for registration as elector:

The Constitution provides that appropriate legislature may prescribe any disqualifications for registration as elector on the ground of non-residence, unsoundness of mind, crime or corrupt or illegal practice at an election (Article 326). Such disqualifications for registration as an elector have been prescribed by Parliament in Section 16 of the Representation of the People Act 1950. According to that section, a person shall be disqualified for registration in an electoral roll, if he:-

- 1. Is not a citizen of India: or
- 2. Is of unsound mind and stands so declared by a competent court: or
- 3. Is for the time being disqualified from voting under the provisions of any law relating to corrupt practices and other offences in connection with election.

#### **Proof of Ordinary Residence:**

The Election Commission has directed that while establishing the fact of ordinary residence of an applicant, the Electoral Registration Officer may ask for a copy of any of the following documents alongwith Form-6, as a proof of ordinary residence:-

- 1. Water/Electricity/Gas connection Bill for that address (at least 1 year)
- 2. Aadhaar Card
- 3. Current passbook of Nationalized/Scheduled Bank/Post Office
- 4. Indian Passport
- 5. Revenue Department's Land Owning records including KisanBahi

- 6. Registered Rent Lease Deed (In case of tenant)
- 7. Registered Sale Deed (In case of own house)

### List of documentary proof of age:-

The Election Commission has prescribed the documentary proof of age:-

- Birth certificate issued by Competent Local Body/Municipal Authority/Registrar of Birth & Deaths
- 2. Aadhaar Card
- 3. PAN Card
- 4. Driving License
- 5. Certificates of Class X or Class XII issued by CBSE/ICSE/State Education Boards, if it contains Date of Birth
- 6. Indian Passport
- 7. Any Other Document for Proof of Date of Birth:- (If no core document is available) (As per ECI Lr.No.3/ER/2021/SRR/Vol.II dated 23-06-2022 (Amendment in Election Laws and Rules).
- 8. In case none of the above document is available, an oath or affirmation in prescribed format (Annexure 27) made by either of the parent of the applicant (or by guru in case of an applicant in third gender category) can be given. In those cases where parental declaration is given as proof of age, the applicant will have to be present himself for verification before Booth Level Officer/Assistant Electoral Registration Officer/Electoral Registration Officer.
- 9. Further, if none of the above documents is available and neither of the parents is alive, the applicant can submit a certificate of his age given by sarpanch of the concerned Gram Panchayat or by a member of the concerned Municipal Corporation/Municipal Committee.
- 10. In case the applicant is more than 21 years and physically appears to be so to Booth Level Officer/Assistant Electoral Registration Officer/Electoral Registration Officer, declaration of age by him will be taken as proof of age and no documentary proof will be insisted on. The age should be indicated in years and completed months as on the qualifying date i.e. first day of January/first day of April, the first day of July and the first day of October of the year with the reference to which electoral roll is being revised.

## **Procedure for registration of voters on Electoral Rolls:**

- 1. Election Commission allows for enrollment of new voters through Form-6.
- 2. Addition of overseas Indian elector in the Electoral Roll is allowed through form -6A.
- 3. Letter of information of Aadhaar number for the purpose of electoral roll authentication is allowed throughForm-6B.
- 4. Deletion of Electoral entry from Electoral Roll is allowed through form- 7.
- 5. In Form-8, one can apply for only one of the following option at a time.
  - i) Form for shifting of residence (Outside or within assembly constituency)
  - ii) Correction of entries in the existing electoral roll.
  - iii) Replacement of EPIC.
  - iv) Marking of PWD

The aforesaid Forms are available with all the AEROs/EROs offices. One can also apply online through the Portal <a href="https://voters.eci.gov.in">https://voters.eci.gov.in</a>

#### Periodicity of Revision-When to Revise Electoral Rolls:-

The Election Commission orders revision of electoral rolls in every year with reference to four qualifying dates (i.e.) the first day of January, the first day of April, the first day of July and the first day of October of the year in which an electoral roll is finally published.

The activities relating to preparation of electoral rolls are regularly done. The whole exercise of preparation of electoral rolls may be divided mainly into three stages-Prerevision activities, revision process and continuous updation.

#### **Registration at Multiple Places:**

The elector will render himself liable to penal action under Section 31 of the Representation of the People Act, 1950 if he gets his name included in the electoral roll at multiple places despite knowing that his name is already included in the electoral roll and he suppresses that fact by making false declaration in application (Form-6).

## **Polling Stations: -**

We have total 1725 polling stations in the State of Goa out of that 863 Polling Stations are in 1-North Goa Parliamentary Constituency and 862 Polling Stations are in 2- South Goa Parliamentary Constituency.

#### Number of voters :-

Out of the total of  $\underline{11,78,889}$  voters,  $\underline{5,71,139}$  male voters and  $\underline{6,07,738}$  female voters in the State of Goa. We have  $\underline{5,49,961}$  voters in 1-North Goa parliamentary constituency [Male voters- $\underline{2,66,636}$  and Female voters -  $\underline{2,83,322}$ ] and  $\underline{6,28,928}$  voters in 2-South Goa parliamentary constituency [male voters- $\underline{3,04,503}$  and Female voters -  $\underline{3,24,416}$ ].

## **Electors Photo Identity Cards for the voters from Goa State:**

Rule 28 of the Registration of Electors Rules, 1960 provides for identity cards for electors.

If name is registered in the Electoral Roll of the concerned Assembly Constituency, then you will be eligible for issue of Electoral Photo Identity Card (EPIC).

As per the directives from the Election Commission of India, the EPICs are distributed to the electors through Speed post at their residence.

#### **Chief Electoral Officer:-**

The Secretary (Elections), Government of Goa is designated as the Chief Electoral Officer for Goa State. He has to function subject to the superintendence, direction and control of the Election Commission of India, New Delhi and shall supervise the preparation and revision of Electoral Rolls, conduct of Assembly and Parliamentary elections in the State of Goa.

#### **District Election Officers:-**

In the State of Goa the Collector & District Magistrate (North) has been designated as District Election Officer for Nineteen Assembly Constituencies and for 1-North Goa Parliamentary Constituency. The Collector & District Magistrate (South) has been designated as District Election Officer for twenty one Assembly Constituencies and for 2-South Goa Parliamentary Constituency. They shall co-ordinate and

supervise all work in their respective Assembly and Parliamentary Constituencies in connection with preparation and revision of Electoral Roll.

### Electoral Registration Officers and Assistant Electoral Registration Officers: -

In the State of Goa twenty Deputy Collectors, two Chief Officer of Municipal Council, one Deputy Registrar of Co-operative Societies (Tech) and one Dy. Registrar of Goa Engineering College have been designated as the Electoral Registration Officers. To assist the Electoral Registration Officers twelve Mamlatdars and twenty eight Joint Mamlatdars have been designated as Assistant Electoral Registration Officers. The Electoral Rolls for each Constituency in the State of Goa are being revised by the Electoral Registration Officers with the help of the respective Assistant Electoral Registration Officers as per the program fixed by the Election Commission of India, New Delhi.

#### **Booth Level Officers:-**

Booth Level Officers are to be appointed by the Electoral Registration Officer under Section 13B (2) of the Representation of the People Act, 1950 after obtaining approval of the District Election Officer. They shall deem to be on deputation of the Election Commission of India under section 13CC of the Representation of People Act, 1950.

#### **Duties of Booth Level Officer:-**

The Booth Level Officers play vital role in preparation and revision of electoral rolls, for which they shall make a thorough study of the roll of the part assigned to them and shall make frequent field visits to the areas in the said part and interact with local people, particularly, elders and grass root level elected representatives and identity the names of the dead/shifted duplicate voters in the roll.

# Returning Officers and Assistant Retuning Officers for Parliamentary Constituencies:-

The Collector & District Magistrate (North) has been designated as Returning Officer for 1-North Goa Parliamentary Constituency and the Collector & District Magistrate (South) has been designated as Returning Officer for 2-South Goa Parliamentary Constituency. To assist the Retuning Officer for 1- North Goa Parliamentary

Constituency and 2-South Goa Parliamentary Constituency, twenty Deputy

Collectors, two Chief Officer of Municipal Council, one Deputy Registrar of Co-

operative Societies (Tech) and one Dy. Registrar of Goa Engineering College have

been designated as Assistant Returning Officers. The Returning Officer for each

Constituency undertakes the work related to Parliamentary election subject to the

superintendence, directions and control of the Election Commission of India, New

Delhi and the Chief Electoral Officer of Goa State.

Returning Officers and Assistant Returning Officers for Assembly

Constituencies:-

In the State of Goa twenty Deputy Collectors, two Chief Officer of Municipal Council,

one Deputy Registrar of Co-operative Societies (Tech) and one Dy. Registrar

Engineering College have been designated as the Retuning Officers for Assembly

Constituencies in North Goa and South Goa District. To assist the Retuning Officers

twelve Mamlatdars and twenty eight Joint Mamlatdars has been designated as

Assistant Retuning Officers. They have to carryout the election work as per the

instructions, guidelines received from the Election Commission of India and the

Chief Electoral Officer of Goa State.

#### **State Contact Centre:-**

There is a State Level Call Centre and voter helpline 1950 which is operating from Office of Chief Electoral Officer. The SCC provides information, addresses complaints, invites suggestions and records the feedback, which is a powerful complaint monitoring tool. In addition, we also have Voters Facilitation Centres (VFC) Taluka wise which provide the required the assistance to the Electors.

## **Delimitation of Assembly and Parliamentary Constituencies**

The Election Commission of India, New Delhi has divided the State of Goa into 40 Territorial Constituencies for the purpose of election of Legislative Assembly and into two Parliamentary Constituencies for the purpose of election of Parliament vide their Notification No. 282/1/GOA/89 dated 31-01-1989.

# Systematic Voter's Education and Electoral Participation (SVEEP) activities.

SVEEP activities has now taken the prime position for awareness for greater participation in election activities to electors. Hon'ble Election Commission has introduced SVEEP platform to make election inclusive, accessible to reach out to all electors. It is the motto of ECI that no voter to be left behind and to keep up this motto various activities are being carried out to activate prospective voters, young voters, newly enrolled electors, senior citizens electors, PwD electors of 21 categories, transgenders, sex workers. Different types of activities are planned, discussed, carried out under the directions of CEO and Addl. CEO. The dynamic ideas are being executed at the election and like green polling stations concept was introduced with a motive to save environment to encourage the local artisans. Polling Stations were decorated and eco friendly matersials were tried to use. CEO Office is trying to come up with innovative ideas and creativity like. To encourage women electors pink polling booths concept was introduced, the polling booths were manned by ladies, polling booths were manned by Person with Disabilities (PwD) electors

## **National Voter's Day**

Election Commission of India, New Delhi was established on 25<sup>in</sup> January 1950. In the year 2010, The Government of India has declared this day as National Voter's Day to commemorate of its establishment. In order to create awareness among the public especially in the age group 18-19 years and also 20-29 years, Election Commission of India, New Delhi, directed all the states to organize various activities such as Human Chain, Rallies, various competitions such as essay writing, elocution, Quiz, Street play, slogan, Rangoli, Poster, Short film, debate etc for youth at college level students and also out of school youth for National Voters' Day. ECI also requested all the state and also give wide publicity through print and electronic media.

In the country Goa is the first State where Electronic Voting Machines were successfully used for conducting the Poll in the entire State for last General Elections to Goa State Assembly, 1999 & 2002, 2007, 2012, 2017, 2022 and General Elections to Lok Sabha held in 1999, 2004, 2009, 2014, 2019 & 2024 and so on. The VVPATs were also used in all Polling Stations during recently held Lok Sabha Elections, 2024
